

Project Report:

Relief Aid for Flood-Affected People of Manipur



About the Project

Manipur, nestled in the northeastern region of India, has been under constant stress due to ethnic conflicts and the aftermath of Cyclone Remal, which has caused widespread flooding and destruction. The torrential rains and overflowing rivers have inundated villages, displaced families, and disrupted essential services, leaving thousands homeless, hungry, and vulnerable.

The floodwaters have spared no one, wreaking havoc on communities across Manipur. Families have been uprooted from their homes, livelihoods destroyed, and lives lost. The most vulnerable members of society, including children, women, and the elderly, are facing heightened risks of malnutrition, waterborne diseases, and psychological trauma.

Objectives of this Project:

The people of Manipur urgently require humanitarian assistance to survive and rebuild their lives in the wake of this disaster, and ongoing conflict. Our immediate priorities for intervention include:

1. Shelter: Provision of CGI sheets and construction materials to enable families to rebuild their homes and seek shelter from the elements
2. Bedding: Distribution of bedding items such as linen bedcovers, to ensure a measure of comfort and dignity for displaced families
3. Food & Clothing: Provision of rice and clothing for women to address hunger, malnutrition among the affected population and provide a dignified living for women

The project is aimed to be implemented in July 2024 providing quick relief to the locals.

The funds provided by **SEWA-Canada** were used to procure and distribute shelter roof wall sheets, bedding items, linen sarees and food grains to the flood-affected people of Manipur.

We collaborated with local NGOs such as Sewa Bharati Manipur and international humanitarian organizations to ensure that aid reached those who need it the most in a timely and efficient manner.
